### Overview

This is the amount of federal income tax that was withheld from your gross distribution. This is based upon contributions or payments you made to the Internal Revenue Service (IRS) while working, if any. The 1099-R tax forms are mailed by the end of January each year and available to access and download online by logging in.
