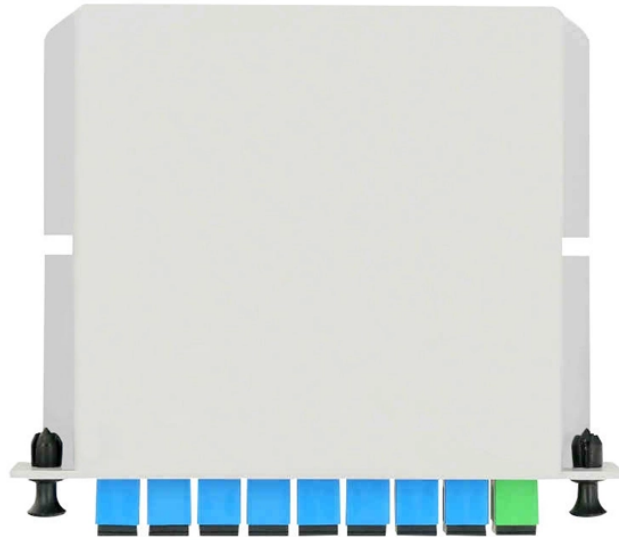


Overview


The HS Code 8544 is the global standard for classifying insulated wires, cables, and fibre optics used in electrical and communication systems. It determines how these products are identified, taxed, and traded across borders. For businesses in the electrical and telecom sectors, knowing the 8544.
