

How to ground communication poles and fiber optic cables



Overview

First of all, we do not ground fiber optic cables. This Applications Engineering Note (AE Note) discusses conventional bonding and grounding practices for conductive fiber optic cable and hardware installations within the scope of the National Electrical Code (NEC). 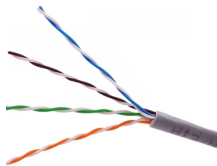
How to ground communication poles and fiber optic cables



Fiber optic cable sequential numbers are required at each pole location and vault wall. Sequential numbers will identify conduit length, and slack left in vaults and at poles.



Deploying fiber above ground on poles or towers removes the need for underground digging and is particularly useful when the ground is uneven, rocky or both. Aerial installation is generally much less ...



This document provides standards and guidelines for aerial installation of fiber optic cables including pole setting, grounding, cable runs between poles, and fiber ...



Go to the far end of the requested cable location area and ground the fiber metallic shield, the metallic stress member, or the locate wire to an independent ground ...



While nonarmored fiber optic cables don't need grounding due to their dielectric properties, armored fiber optic cables feature metallic components that must be earthed appropriately to maintain safety ...



In installations where an optical fiber cable is exposed to contact with electric light or power conductors and the cable enters the building, the non-current-carrying metallic members shall ...



The type of fiber optic cable and the fibers in the cable should be chosen appropriate for the type of communications system(s) being supported, the type of installation and the environment in which the ...



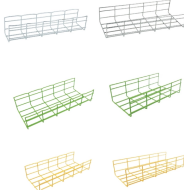
The following applies to all fiber count gel-free and gel-filled armor ribbon cables installed in aerial plant, including down pole pedestal turn-ups: When jacket opening is made for a splice closure, pedestal, ...



Fiber Optic Splice cases. A typical FOCA splice case will have the majority, if not, all cables entering from one side of the splice case, with the opposing end being unoccupied (Figure 4-11).
