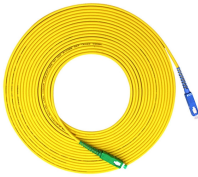

The United States Postal Service (USPS) maintains strict guidelines about mailbox decorations. This regulation is established under Title 18, Section 1725 of the United States Code, which prohibits the placement of mailable and non-mailable.



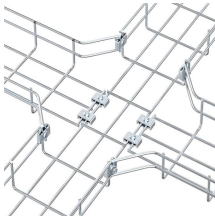

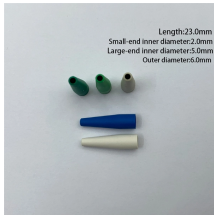
